The committee discussed the existing condition of paratransit service, split fleet roll out, and trip negotiations. Since the September 9th meeting, there have been a decrease in complaints. Paul from Hulmes has hired a company to re-train dispatch and scheduling staff on customer service and members of the committee have volunteered to train on sensitivity issues.
